The equivalent amount of funds held in foreign currency accounts is calculated based on the exchange rate of the Central Bank of the Republic of Uzbekistan on the date of calculating the average monthly balance/regular income for the billing month

² When determining the amount of the commission payable by the client for the billing month, the average monthly balance for the respective month is taken into account. This balance is calculated by dividing the total sum of daily balances across all accounts by the number of calendar days in the billing month for which the payment is made

³ Salary, rental payments for leasing property (real estate, equipment, etc.), dividends, interest on deposits, transfers from individuals, non-cash and cash inflows

⁴ When determining the amount of the commission payable by the client for the billing month, the total amount of regular inflows/income over the previous 3 months is taken into account. This amount is calculated by dividing the total income received during the past 3 months by the number of months

⁵ Payment of the service maintenance fee does not exempt the client from paying fees for other services specified in these tariffs
