3.Except for incoming funds from accounts of legal entities and individual entrepreneurs who are clients of Ipoteka Bank, as well as for loan disbursements by Ipoteka Bank branches to cards.

4.For tuition fee payments to higher education institutions: 2% (min. 20,000 UZS);
for "Umrah" and "Hajj" payments: free of charge.
